

# Steamboat Trip - Feb 20 - 27, 2010

- 5 days of Lift Tickets (\$25 gets you a 6<sup>th</sup> day)

## Trip Costs

- The lodging options for 2 in a room are \$960 - 1050 depending on which type of condo you choose
- That cost includes 5 days of lift tickets, parties, Mountain tour, Nastar race, Thursday Banquet
- Specifying a single room (one person in a room) adds about \$500 to your week
- Note that the rooms with twin beds and bunk beds are going fast
- Flights out of SYR are running \$400 - \$540 (Our air destination is Hayden airport code HDN)
- Trip insurance is available for 5% of the trip cost, which is about \$75 (Recommended)
- Airline luggage costs are typically \$40 - 50 each way for typical ski trip goers
- Ground transportation from and to the airport may be \$20 each way. It depends on when your flight arrives and leaves. If your flights are in sync with the primary NJSC trip flights out of Newark, then there is no extra charge for ground transportation. Contact Tim Hanna for details.
- Trip payments are made to New Jersey Ski Council, Inc.
- Airfare payments are made to NJSC's travel agent, Sports America, Inc

## The Phoenix Condos



The Phoenix Condominiums offer 2 bedroom 2 bath, 3 bedroom 3 bath and 4 bedroom 4 bath units. Each unit includes fully equipped kitchen with breakfast bar, cable TV/HBO/VCR, switchboard telephone service, gas fireplace, private balcony, and stacked washer and dryer.

- Walking distance to the gondola (about one block)
- Spa area has outdoor heated pool, two hot tubs and exercise room.
- Exercise equipment on premises.
- Daily light clean which includes towels changed and trash removed for stays of 3 or more nights. There is a mid-week complete cleaning for stays of 6 nights or more. Two night stays will have towels and linens provided, but no maid service.

**Note:** Airlines are now charging for second checked bag (\$25) and some are charging for first checked bag (\$15.) Airfare quotes do not include cost of checking baggage. The baggage charges need to be paid by you at the airport when checking your bags.

**SKI AND PARTY INFORMATION:** Five-day lift ticket – Good for 5 out of 6 days at Steamboat. Optional 6<sup>th</sup> day for \$25.00 if pre-ordered. Welcome Party, Mountain tour, Nastar Race, On-the-mountain picnic, Après-ski party, and Awards Banquet.
